# Trusted Traveler Programs

## TRUSTED TRAVELER PROGRAMS.

The Department of Homeland Security (DHS) has many Trusted Traveler programs which provide both an enhanced traveler experience and increased safety and security. These programs offer various benefits for frequent flyers. Please see below for information on which program may be best for you.

### PROGRAMS:

- **TSA Pre<sup>√</sup>**™ (for travelers who primarily fly within the US) is a government program that allows select frequent flyers of participating airlines and members of US Customs and Border Protection (CBP) Trusted Traveler programs who are flying on participating airlines to receive expedited screening benefits at select airports. TSA Pre<sup>√</sup>™ is available for passengers traveling domestically within the US and for international travel when departing from a participating TSA Pre<sup>√</sup>™ US airport location. The TSA Pre<sup>√</sup>™ application program is also available to travelers and allows pre-approved, low-risk travelers the opportunity to apply for expedited screening at participating US airports through select enrollment centers.
- **Global Entry** (for travelers who fly within the US and internationally) is a US CBP program that allows expedited clearance for pre-approved, low-risk travelers upon arrival in the US at select airports. All applicants undergo an extensive background check and interview before enrollment. Members of this program are automatically eligible for the TSA Pre<sup>√</sup>™ benefits and do not need to apply separately for that program.
- **NEXUS** (for travelers who primarily travel between the US and Canada) is a US and Canadian CBP program that allows pre-screened travelers expedited processing by US and Canadian officials at dedicated processing lanes at designated northern border ports of entry, at NEXUS kiosks at Canadian preclearance airports, and at marine reporting locations. Members of this program are automatically eligible for the TSA Pre<sup>√</sup>™ benefits and do not need to apply separately for that program.
- **SENTRI** (for travelers who primarily travel by land between the US, Canada, and Mexico) is a US, Canada, and Mexico CBP program that provides expedited CBP processing for pre-approved, low-risk travelers at land border ports of entry. Members of this program are automatically eligible for the TSA Pre<sup>√</sup>™ benefits and do not need to apply separately for that program.
- **CLEAR** (for travelers who primarily fly within the US) is a non-governmental, privately operated program that provides expedited screening benefits to frequent flyers on any airline at select US airports. CLEAR is available for passengers traveling domestically within the US and for international travel when departing from a participating CLEAR US airport location. CLEAR can be integrated with TSA Pre<sup>√</sup>™ for enhanced traveler screening benefits.
- **Secure Flight** is a behind-the-scenes program that enhances the security of domestic and international commercial air travel through the use of improved watch list matching. The requirement to collect full name, date of birth, gender, and redress number are federally mandated by the TSA's Secure Flight Program in order to travel by air. Collecting additional passenger data improves the travel experience for all airline passengers, including those who have been misidentified in the past.
